Spring Forward On Sunday March 14 at 2 AM Turn your clocks 1 hour forward before you go to bed on Saturday March 13th

It's also a good time to schedule maintenance on essential household items:

- Replace smoke alarm batteries and test the alarm.
- Check your carbon monoxide monitors.
- Clean your dryer vent. The dryer vent should be cleaned at least every six months to prevent fire hazards.
- Check all your appliance filters to ensure optimum efficiency. This includes furnace and air conditioning air filters, vacuum cleaners, refrigerators water filters, dishwasher filters and air purifiers and humidifiers.
- Schedule a cooling system check. Make sure your HVAC is working properly before the heat of summer hits.
- Have your water heater drained to remove sediment and improve efficiency. This should be done once a
 year.

Architectural Review Rules

Before installing those outdoor sheds, patios or decks, any changes or additions to your home or major changes to your landscaping need prior ARC approval. Major additions must be staked for visual reference to assess impact to adjoining properties. The HOA has 30 days to review submissions to ARC. Regulation Reminder

Topic: Pets

Pets shall be attended at all times and shall be registered, licensed, and inoculated as may from time to time be required by law. Pets shall not be permitted upon the Common Area unless accompanied by a responsible person and unless they are carried or leashed. The Board of Directors shall have the right to adopt such additional rules and regulations regarding pets as it may from time to time consider necessary or appropriate.
